While participants to each meeting will ultimately guide the related topics and discussion, it is anticipated that the overall structure of each meeting will include the following:

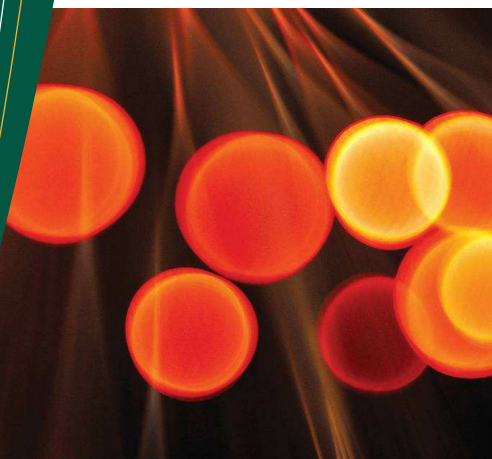
Time - 9:00 a.m. to 2:00 p.m.
