The Workplace Hazardous Materials Information System (WHMIS), Canada’s national hazard communication standard, has changed to incorporate the Globally Harmonized System of Classification and Labelling of Chemicals (GHS) – an internationally recognized standard for hazard classification and communication.

Health Canada, the federal government department responsible for WHMIS, has amended the current federal WHMIS legislation to align with GHS.

OABA’s new offering addresses the changes to WHMIS and includes:

- Employee education and training
- New hazard pictograms
- New hazard classes
- New labels and their required elements, such as signal words and precautionary statements
- New standardized 16-section Safety data sheet (SDS)
- The new SDS format and how to locate information needed to work safely with a product
