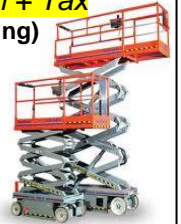

Working at Heights Checklist for Participants

***Photo Identification:** The Ministry of Labour (MOL) requires each participant to produce photo identification prior to the beginning of the training session (driver's license, passport, resident card with proper mailing address). Participants without proper identification will **NOT** be allowed to participate.

***Course Payment:** *Payment is required prior to the date of training.* ACUTE accepts Visa/MasterCard/Debit.

***Arrival Time:** *Participants should arrive 15 minutes prior to training.* This will allow time to complete payment, and fill in the Ministry of Labour (MOL) registration forms prior to the start of the course. Late participants will **NOT** be admitted into the course.

***What to Wear:** The course includes hands-on use and wearing of fall protection equipment. You will be wearing a full body harness for a portion of the course. Please wear comfortable clothing and closed toe foot wear. **DO NOT** wear sandals, flip flops, or open toe footwear!

***Full Day:** *Participants must be present for the full day of training.* Each participant must complete the course quiz scoring at least 75%. Each participant must also demonstrate the ability to inspect and wear/set-up various fall protection equipment.

***Certificate/Wallet Card:** A wallet card and certificate will be issued at the successful completion of the course. The Chief Prevention Office (CPO) will mail each successful participant a CPO issued proof of completion card at a later time.

Checklist for Participants

ACUTE can confirm learner eligibility in one of four ways:

1. Viewing the learner's CPO-issued proof of completion card
2. Viewing the proof of completion card issued by the approved training provider
3. Matching the learner to a record of training in the training provider's database
4. Viewing any record of training from the employer that meets the requirements in O.Reg 297/13 section 10 (must include the name of the worker, the name of the of CPO-approved training provider, the name of approved training program and the date of successful completion of training)

A Ministry of Labour (MOL) learner ID number alone is not sufficient proof of successful training completion for training providers to validate eligibility for refresher training.

If none of the above options are available, contact the MOL to obtain a record of training. Ministry of Labour Contact Centre at **1-877-202-0008**.

Photo Identification: Government issued photo ID must be presented.

Course Payment: Payment is required prior to the date of training.

Arrival Time: Course begins at 8:30am, please arrive 15 minutes prior. Late participants will not be admitted and payment will be forfeited.

What to Wear: The course includes hands-on use and wearing of fall protection equipment. You will be wearing a full body harness for a portion of the course. Please wear comfortable clothing and closed toe foot wear. **DO NOT** wear sandals, flip flops, or open toe footwear!

Certificate/Wallet Card: A wallet card and certificate will be issued at the successful completion of the course. The Chief Prevention Office (CPO) will mail each successful participant a CPO issued proof of completion card at a later time.

JHSC Certification Part 1 & Part 2

Any company that regularly employs 20 or more workers is required to create a Joint Health and Safety Committee. At least one worker representative and one management representative must be certified.

JHSC Certification Part 2 must be completed within six months of JHSC Certification Part 1 training.*

A one day refresher is required every three years to keep your JHSC Certification.



*The Chief Prevention Officer may grant a one-time six month extension to complete Part 2.
